NOTICE OF PUBLIC HEARING

A hearing will be held August 31, 2020 at noon at the Clay County Public Health Center, 800 Haines Drive, Liberty, Missouri 64068 for the purposes of establishing and setting the tax rate for the Clay County Public Health Center. The tax rate to be established is to produce revenue necessary for the Health Center's FY2021 operating budget for the period of January 1, 2021 – December 31, 2021.

The following assessed valuations have been reported by the Clay County Clerk on August 21, 2020, upon which the tax levy shall be calculated.
